

## **“Minum, Makan & Menang” Contest Terms and Conditions**

### **Eligibility:**

1. The "Minum, Makan & Menang" ("The Contest") is organized by 7-Eleven Malaysia ("The Organizer") shall be held from 16<sup>th</sup> May 2017 to 24<sup>th</sup> July 2017 ("Contest Period").

Unless an Extended Period is announced, any entries received after last day of the contest period (due to any reason howsoever and/or whatsoever arising) shall be disqualified. Any participation in the Contest during the Extended Period (if any) shall be governed by these terms and conditions ("Terms and Conditions"), which shall remain in full force and effect.
3. The Contestants must be citizens or permanent residents of Malaysia and above the age of eighteen (18) years with a valid National Registration Identification Card (NRIC) number (12-digit) at the time of participation of the Contest.
4. The following persons are not eligible to participate in the said Contest:
