

## **“Pay & Ride” Contest Terms and Conditions**

### **Eligibility:**

1. The "Pay & Ride" ("The Contest") is organized by 7-Eleven Malaysia Sdn. Bhd. and Tenaga Nasional Berhad ("The Organizer") shall be held from 1<sup>st</sup> December 2017 to 31<sup>st</sup> December 2017 (Round 1) and 1<sup>st</sup> January 2018 to 31<sup>st</sup> January 2018 (Round 2) ("Contest Period").
2. The Organizer may at its sole and absolute discretion extend the Contest Period at any time without any prior notice. Unless an Extended Period is announced, any entries received after last day of the contest period (due to any reason howsoever and/or whatsoever arising) shall be disqualified. Any participation in the Contest during the Extended Period (if any) shall be governed by these terms and conditions ("Terms and Conditions"), which shall remain in full force and effect.
3. The Contestants must be citizens or permanent residents of Malaysia and above the age of eighteen (18) years with a valid National Registration Identification Card (NRIC) number (12-digit) or Army Number/ Police Number/ Company's Registration number at the time of participation of the Contest.
4. The following persons are not eligible to participate in the said Contest:
  - a. Permanent and/or contract employees of the Organizer (including its subsidiaries and related companies), including but not exclusive to their respective immediate family members, meaning parents, spouses, children and siblings;
  - b. Representatives and/or agents (including advertising agents and contest management agents) of the Organizer, including but not exclusive to their respective immediate family members, meaning parents, spouses, children and siblings.

### **The Contest & Submission:**

5.0 Contestants are required to complete the following steps to participate in the Contest:

#### **Step 1**

A qualified participant must pay TNB bill at any 7-Eleven outlets within the Contest Period.

- TNB account must be active
  - Minimum bill payment of RM50
- OR
- Full bill payment (RM50 or more)

#### **Step 2**

After payment is made, request a copy of your payment receipt from the cashier.

#### **Step 3**

Answer one (1) question by filing up the contest form and attach the bill payment receipt. Submit your entry to the cashier or place your entry into the contest box or send in to 7-Eleven Malaysia Sdn Bhd, Marketing Department, Level 3A, Podium Block, Plaza Berjaya, No. 12, Jalan Imbi, 55100 Kuala Lumpur.

5.1 Contestants may submit as many entries as they wish. 1 bill payment receipt is equivalent to 1 entry. The higher the number of entries submitted, the higher the chances of winning. Incomplete or ineligible Entries will be disqualified.

5.2 Bill payment receipt must be following the Contest Period. For example, bill payment receipt dated 31<sup>st</sup> December 2017 will not be accepted as Entry/ Entries for Round 2).

5.3 Completed Entry/ Entries for Round 1 must be accepted or send in before 6pm on 31<sup>st</sup> December 2017 and Round 2 before 6pm on 31<sup>st</sup> January 2018.

5.4 The Organizer will not be held liable for Entry/Entries that are not received, damaged or lost during delivery process. These Entry/Entries shall be considered void.

5.5 Incomplete, illegible and incorrect entries and those without proof of TNB's bill payment will be disqualified.

5.6 Proof of Entry/Entries sent cannot be used, as is not proof of Entry/Entries received.

5.7 The Organizer reserves the absolute right to reject Entry/Entries at its sole and absolute discretion without having to assign any reason whatsoever.

6.0 Each Contestant is entitled to win one (1) Prize only during the Contest Period. Prize fulfillment would take place within three (3) weeks after the Contest Period ends.

6.1 The Prizes must be collected in person at the Organizer's office at Level 1, Podium Block, Plaza Berjaya, No. 12, Jalan Imbi, 55100 Kuala Lumpur, unless advised otherwise, no later than three (3) weeks after winner announcement has been made.
