Dear Shareholders,

With reference to the revised 'Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers' issued by the Securities Commission Malaysia ("**SC's Guidance**") on 7 April 2022, listed issuers are encouraged to continue leveraging technology in conducting general meetings beyond Movement Control Order.

In line with the Malaysian Code on Corporate Governance Practice 13.3, the Company's forthcoming 11th AGM will be conducted virtually through live streaming and Remote Participation and Electronic Voting ("RPEV") facilities from the Broadcast Venue. This would facilitate greater shareholder participation as it facilitates electronic voting and remote shareholders' participation. With the RPEV Facilities to be provided by the Poll Administrator of the Company, Boardroom Share Registrars Sdn. Bhd. ("Boardroom"), you may exercise your right as a member of the Company to participate (including to pose questions to the Board of Directors and/or Management of the Company) and vote at the 11th AGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the 11th AGM.

Kindly ensure that you are connected to the internet at all times in order to participate and vote when our virtual 11th AGM has commenced. Therefore, it is your responsibility to ensure that connectivity for the duration of the meeting is maintained. Kindly note that the quality of the live webcast is dependent on the bandwidth and stability of the internet connection of the participants.

Broadcast Venue

A virtual 11th AGM will be conducted online from the Broadcast Venue, and shareholders will participate via the RPEV facilities with audio and/or video capabilities. The Broadcast Venue is the main venue in Malaysia where the Chairman of the meeting will be physically present in accordance with Section 327(2) of the Companies Act 2016 ("the Act") together with essential individuals in accordance with Note 1.3 of the SC's Guidance. Shareholder(s), proxy(ies), authorised representative(s) or attorney(s) WILL NOT BE ALLOWED to be physically present at the Broadcast Venue on the day of the 11th AGM.

Entitlement to Participate and Vote

Only shareholders whose names appear in the Record of Depositors as at 23 May 2024, or their appointed proxy(ies), shall be entitled to participate and vote remotely at the 11th AGM.

Lodgement of Form of Proxy

Shareholders are encouraged to go online, participate, and vote at the AGM using RPEV facilities. If you are unable to attend the 11th AGM, you are strongly encouraged to appoint the Chairman of the 11th AGM as your proxy and indicate the voting instructions in the Form of Proxy in accordance with the notes and instructions printed therein.

If you wish to attend the 11^{th} AGM yourself, please do not submit any Proxy Form. You will not be allowed to attend the 11^{th} AGM together with a proxy appointed by you.

Please ensure that the original Form of Proxy is deposited at our Share Registrar's office, at 09-27 Level 9, Berjaya Times Square, No. 1 Jalan Imbi, 55100 Kuala Lumpur, Wilayah Persekutuan, Malaysia, not less than forty-eight (48) hours before the time appointed for holding the 11th AGM.

Alternatively, the proxy appointment may also be lodged electronically via Boardroom Smart Investor Portal at https://investor.boardroomlimited.com, which is free and available to all individual shareholders, not less than forty-eight (48) hours before the time of holding the AGM, i.e. latest by 28 May 2024 at 10.00 a.m. For further information on the electronic lodgement of Proxy Form, kindly refer to the "e-Proxy Lodgement" below:-

- e. Your registration will be verified and approved with one (1) business day and an email notification will be provided.

- e. Select the company you would like to be represented (if more than one) for Corporate Shareholder.
- f. Enter your CDS Account Number and indicate the number of securities held.
- g. Select your proxy either the Chairman of the meeting or individual named proxy(ies).
- h. Read and accept the General Terms and Conditions by clicking "Next".
- i. Enter the required particulars of your proxy(ies).
- j. Indicate your voting instructions FOR or AGAINST, otherwise your proxy(ies) will decide your votes.
- k. Review and confirm your proxy(ies) appointment and click "Apply".

- a. Access website https://investor.boardroomlimited.com
- b. Login with your User ID and Password given above.
- c. Click "Meeting Event" and select from the list of companies "7-ELEVEN MALAYSIA HOLDINGS BERHAD ELEVENTH (11th) ANNUAL GENERAL MEETING" and click "ENTER".
- d. Click on "Submit eProxy Form".
- e. Select the company you would like to be represented (if more than one).
- f. Proceed to download the file format for "Submission of Proxy Form".
- g. Prepare the file for the appointment of proxy(ies) by inserting the required data.
- h. Proceed to upload the duly completed Proxy Appointment file.
- i. Review and confirm your proxy(ies) appointment and click "Submit".
- j. Download or print the eProxy form as acknowledgement.

Alternatively, you may also write to <u>bsr.helpdesk@boardroomlimited.com</u> and provide the name of the shareholder, CDS account no. and the Certificate of Appointment of Corporate Representative or Proxy Form (as the case may be). A copy of MyKad or passport and a valid email address are required.

Note: If you are the authorized representatives for more than one (1) authorized nominee / exempt authorized nominee/ corporate shareholder, kindly click the home button and select "Edit Profile" in order to add Company name.

Revocation of Proxy

If you have submitted your Form(s) of Proxy and subsequently decide to appoint another person or wish to participate in our electronic 11th AGM by yourself, please write in to bsr.helpdesk@boardroomlimited.com or via Boardroom Smart Investor Portal at https://investor.boardroomlimited.com (as the case maybe) to revoke the earlier appointed proxy forty eight (48) hours before the AGM. On revocation, your proxy(ies) will not be allowed to participate in the AGM. In such event, you should advise your proxy accordingly.

Voting Procedures

The voting will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad's Main Market Listing Requirements. The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting (e-Voting) and SKY Corporate Services Sdn. Bhd. as Independent Scrutineer to verify the poll results.

During the 11th AGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules.

For the purpose of this 11^{th} AGM, e-Voting can be carried out by using either personal smart mobile phones, tablets, personal computers or laptops.

The polling will only commence after announcement of poll being opened by the Chairman and until such time when the Chairman announces the closure of poll.

The Independent Scrutineer will verify the poll result reports upon closing of the poll session by the Chairman. Thereafter, the Chairman will announce and declare whether the resolutions put to vote were successfully carried or otherwise.

Online Registration Procedure

Please note that all members including (i) individual members; (ii) corporate shareholders; (iii) authorised nominees; and (iv) exempt authorised nominees shall use the RPEV facilities to participate and vote remotely at the AGM.

If you wish to participate in the AGM, you will be able to view a live webcast of the 11^{th} AGM, ask questions and submit your votes in real time whilst the 11^{th} AGM is in progress.

Kindly note that the quality of the live streaming is highly dependent on the bandwidth and stability of the internet connection of the participants. Therefore, kindly ensure that connectivity for the duration of the meeting is maintained.
