### **ELIGIBILITY TO ATTEND BASED ON THE RECORD OF DEPOSITORS**

Only shareholders whose name appears on the Record of Depositors as at 15 May 2026 is entitled to attend, participate, speak and vote at the 13<sup>th</sup> AGM or appoint proxies or in case of a corporation to appoint corporate representative(s) to attend, participate, speak and vote on his/her behalf in respect of the number of shares registered in his/her name at that time by submitting the duly executed Form(s) of Proxy.

### **APPOINTMENT OF PROXY(IES)**

A shareholder who is unable to attend the 13<sup>th</sup> AGM on 22 May 2026 may appoint proxy or the Chairman of the Meeting as your proxy and indicate the voting instructions in the Form of Proxy.

Alternatively, the individual shareholder may appoint their proxy(ies) electronically ("E-Proxy Lodgement") via the Berjaya Registration Portal at <https://www.berjayaregistration.com.my> (Domain Registration No. D1C537807-MYNIC) by the last date and time as stipulated below.

For E-Proxy Lodgement, the individual shareholder is required **to register as a user** of the Berjaya Registration Portal ("the registration"). The procedures for the registration and the E-Proxy Lodgement are set out in **Appendix I**.

### **REVOCACTION OF PROXY**

If you have submitted your Form of Proxy either in hard copy or by electronic means prior to the AGM, and subsequently, you have decided to appoint another person or wish to participate in the 13<sup>th</sup> AGM yourself, please write to the Share Registrar at [shareg@berjayareg.com.my](mailto:shareg@berjayareg.com.my) to revoke your earlier appointed proxy(ies) at least forty-eight (48) hours before the AGM.

Upon revocation, your appointed proxy(ies) will not be allowed to participate in the 13<sup>th</sup> AGM. In such event, you should advise your proxy(ies) accordingly.

### **REGISTRATION ON THE DAY OF 13<sup>TH</sup> AGM**

Attendees are requested to produce/show their **ORIGINAL** MyKAD (for Malaysian) or Passport (for non-Malaysian) to the registration personnel for verification purposes. Kindly ensure the original MyKAD or Passport is returned to you thereafter. Please take note that no person will be allowed to register on behalf of another person, even with the original MyKAD or Passport of that person.

### **VOTING PROCEDURE**

Pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, the voting at the AGM will be conducted by poll. The Company has appointed Berjaya Registration Services Sdn Bhd as Poll Administrator to conduct the poll voting and Symphony Corporate Services Sdn Bhd as Independent Scrutineers to verify and validate the poll results.

2. Door gift will be provided to shareholders/proxies in the following manner:
  - (a) One (1) door gift for one (1) shareholder.
  - (b) For a shareholder who has been appointed as a proxy by another shareholder, he/she is entitled to one (1) door gift only.
  - (c) For a shareholder who appoints more than one (1) proxy, door gift will only be provided to the first two (2) proxies stated in the Proxy Form.
  - (d) If a proxy represents more than one (1) shareholder, he/she is entitled to one (1) door gift only.
  - (e) If the proxy/proxies has/have collected the door gift earlier, shareholder(s) who decided to attend and request to revoke the proxy appointment will not be given any door gift.

**E-Proxy Lodgement**

**Steps (applicable for individual shareholders ONLY)**

**1. Registration as a User of the Berjaya Registration Portal**

- Access the Berjaya Registration Portal at <https://www.berjayaregistration.com.my>
- Click <Login/Register> followed by <Register New User> to register as a new user.
- Please complete your registration by filling up the information required and upload a clear copy of your MyKAD (both front and back) or passport.
- You are required to read and agree to the terms and conditions before clicking on <Submit> on the registration page.
- Please enter a valid email address in order for you to receive a verification email from Berjaya Registration.
- An email notification will be sent to you once your registration is verified and approved by Berjaya Registration.
- If you are an existing registered user of the Berjaya Registration Portal, you do not need to register again.

**2. E-Proxy Lodgement via Berjaya Registration Portal**

- An individual shareholder who has registered with Berjaya Registration Portal will be able to lodge the E-Proxy Form by logging into the Berjaya Registration Portal.
- Login to the Berjaya Registration Portal at <https://www.berjayaregistration.com.my> with your User ID and password.
- Click <E-Proxy Lodgement>, search for the 7-Eleven Malaysia Holdings Berhad 13th AGM and click <Choose>.
- Fill up the required information in the E-Proxy Form and indicate your voting by selecting <For> or <Against>. If no specific direction is given, the proxy will vote or abstain from voting at his/her discretion.
- Kindly review and check your completed E-Proxy Form and agree to the terms and conditions before clicking on <Submit> for submission of the E-Proxy Form.
