

TERMS AND CONDITIONS

Organiser & Qualifications

1. This “**Adventurous Travel with 7-Eleven Contest**” Contest [**Contest**] is jointly organised by 7-Eleven Malaysia Sdn Bhd (Registration No: 198401008445 (120962-P)).
2. This Contest is open to 18 years old and above and is either a Malaysian citizen and has a valid identification document during the Contest Period [**Participant**]. By submitting the entry in this Contest, all participants (“Participants”) are deemed to have read, understood and agreed to be bound by these Terms and Conditions (“T&Cs”).
3. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organiser [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or
 - Representatives, employees and/or the advertising agencies or promotional agencies of the Organiser [including its associated and related companies], and their immediate family members [children, parents, siblings, spouses].
